**ARTICLES OF ORGANIZATION  
OF  
LARGO BIKER RUM, LLC**

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act, Chapter 605, Florida Statutes.

**ARTICLE I - NAME**

The name of the limited liability company is LARGO BIKER RUM, LLC (the "Company").

**ARTICLE II - ADDRESS**


**ARTICLE VIII - DATE OF EXISTENCE**


