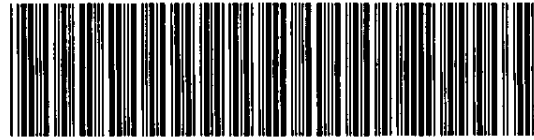

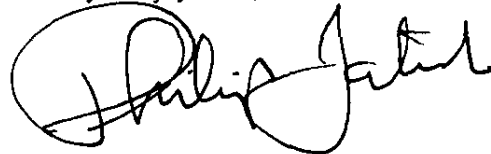

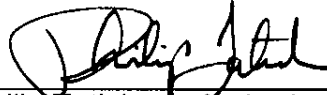
ARTICLE V
