

## ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF POMPANO 2121 LEC 19-PM 1: 02

Pursuant to section 605.0202, Florida Statutes, the members of Portipario 2321. LLC, a Florida Limited Liability Company, hereby file these Articles of Amendment to Articles of Organization for Pompano 2121 LLC (hereinafter "the LLC") is made and entered into this January 1, 2022, by and between all members of the LLC who have affixed their signature hereto as of this date.

The members wish to amend the Articles to admit a new members to the limited liability company, which is the reason for this Amendment.

The members hereby amend the original Articles of Organization previously entered filed May 9, 2017, (hereinafter "Original Articles of Organization"), and Document No. L17000102299.

**NOW, THEREFORE**, in consideration of the foregoing and the mutual agreements contained herein, and intending to be legally bound, the members agree and contract as follows:

The undersigned certify that we have associated ourselves together for the purpose of becoming a limited liability company under the laws of the STATE OF FLORIDA, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. We further declare that the following Articles shall serve as the Charter and authority for the conduct of business of the limited liability company.

#### ARTICLE I. NAME AND PRINCIPAL PLACE OF BUSINESS
