ARTICLES OF ORGANIZATION
OF FIVE BOYS FARM, LLC

The undersigned authorized representative of a Member of a limited liability company pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, does hereby submit the following Articles of Organization:

ARTICLE I. NAME - The name of the company shall be Five Boys Farm, LLC.
