ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
FOR
YBOR BEVERAGE COMPANY, LLC

The undersigned, desiring to amend the Articles of Organization for YBOR BEVERAGE COMPANY, LLC, a Florida limited liability company, under and pursuant to Chapter 605, Florida Statutes, does hereby adopt the following Articles of Amendment to the Articles of Organization for such company:

1. The Articles of Organization for YBOR BEVERAGE COMPANY, LLC were filed on May 11, 2017 and assigned document number L17000105010.
2. The following amendment to the Articles of Organization was adopted by the limited liability company: Article IV is hereby deleted in its entirety and replaced with the following:

ARTICLE IV. MANAGEMENT

This Company shall be a manager-managed limited liability company. The manager shall be Lauren A. Minberg with an address of 1925 East 6th Avenue, Tampa, FL 33605.


3. The following amendment to the Articles of Organization was adopted by the limited liability company: A new Article VI is hereby added, as follows:

ARTICLE VI. INDEMNIFICATION

This Company shall indemnify any member, manager, officer, director, employee, or agent, and any former member, manager, officer, director, employee, or agent, to the full extent permitted by law.

4. All other terms and provisions of the Articles of Organization that were filed with the Secretary of State under document number L17000105010 shall remain unchanged.

These Articles of Amendment to the Articles of Organization are executed this 30 day of May, 2020 and are effective upon filing with the Secretary of State of the State of Florida.
