**AMENDED AND RESTATED  
ARTICLES OF ORGANIZATION  
FOR  
IJS INTERNATIONAL, LLC  
(A Florida Limited Liability Company)**

This Limited Liability Company was formed, upon the filing of the original Articles of Organization with the Florida Secretary of State (Florida document number L17000107371). These Amended and Restated Articles of Organization shall supersede the original Articles of Organization, which have not been previously amended. The Articles of Organization are hereby amended and restated in full as herein set forth:

**ARTICLE I  
NAME**

The name of the Limited Liability Company is amended and shall now be known as **IJS INTERNATIONAL, LLC** (the "Limited Liability Company").

**ARTICLE II  
ADDRESSES**

A. Principal Place of Business. The street address of the principal place of business of the Limited Liability Company shall be 500 S. Cypress Road, #10, Pompano Beach, Florida 33060.
