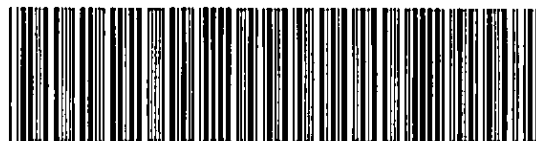



This agreement is made between the first party, Peter Pitesa and the second party Nick Laliotis.


