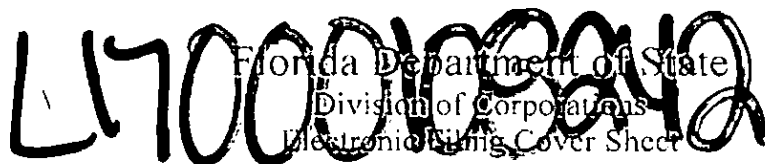

GSFT 2401 CENTRAL, LLC


- FOURTH: Except as hereby amended, the Articles of Organization of the Company shall remain unchanged.
