SECOND: The Articles of Organization for the Company were filed with the Florida Department of State on May 17, 2017, and the Company was assigned Florida Document Number L17000108662;

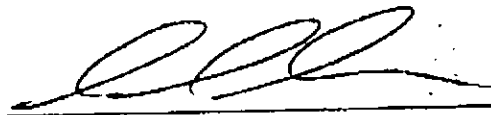
