

Pursuant to Section 605.0202, Florida Statutes, the undersigned hereby submits the following on behalf of **GotDaJuice, LLC**, a limited liability company organized and existing under the laws of the State of Florida:

1. The Articles of Organization of **GotDaJuice, LLC** were filed with the Florida Department of State, Division of Corporations, on May 17, 2017 (such Articles of Organization referred to herein as the "original Articles of Organization").

Article I: The name of the limited liability company is **GotDaJuice, LLC**.




