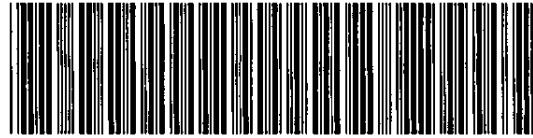

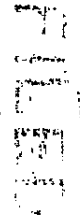

NAME**
