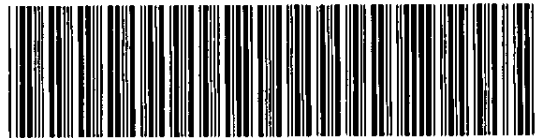

The name of the Professional Limited Liability Company is ACE – JEDI, PLLC.


ARTICLE II — Address


ARTICLE VI — EFFECTIVE DATE

The effective date of the organization of ACE-JEDI, PLLC is May 25, 2017.

ARTICLE VII — NONPROFIT ORGANIZATION

This company plans on applying for tax exempt status with the Internal Revenue Service. No part of the net earnings of the company shall inure to the benefit of, or be distributed to its members, trustees, officer, or other private persons, except that the company shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV. No substantial part of the activities of the company shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a company exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a company, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

This document is executed in accordance with section 605.0203 (1) (b), Florida Statutes. I am aware that any false information submitted in a document to the Department of State constitutes a third degree felony as provided for in s.817.155, F.S.
