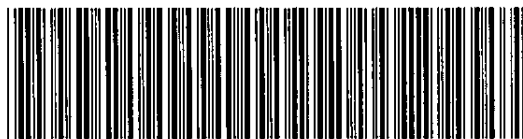

**ARTICLES OF ORGANIZATION
BLACK MEN'S HEALTH, LLC**

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company, pursuant to Chapter 605, Florida Statutes.

Article I – Name

The name of this limited liability company is Black Men's Health, LLC ("Company").

Article II – Mission

Provoking positive change for balanced, healthy lifestyles in men of color everywhere.

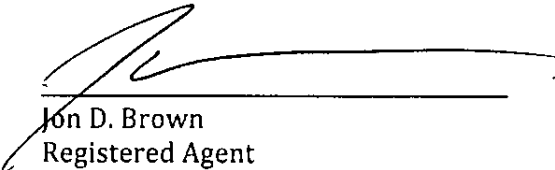
Article III – Mailing Address and Street Address

Article IV – Registered Agent and Office

Article VII – Termination of Membership

If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining members may continue the business of the Company pursuant to the Company's Regulations.

Article VIII – Management of the Company

The management of the company is reserved to the members. The initial managing member will be:

The members shall have the power to adopt, alter, amend, or repeal the Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.

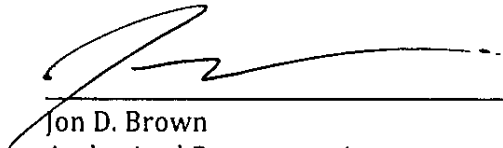
Article X – Date of Existence of the Company
