### ARTICLE I

# ARTICLE VII ADMISSION OF ADDITIONAL MEMBERS

No Member of the Company has the right to withdraw or reduce his capital contribution to the Company except upon the written consent of all existing members.

#### ARTICLE X BUSINESS PURPOSE

The purpose of the Company is to engage in any lawful act or activity for which a limited liability company may be organized under the Florida Limited Liability Company Act, as amended from time to time.
