Place of Business

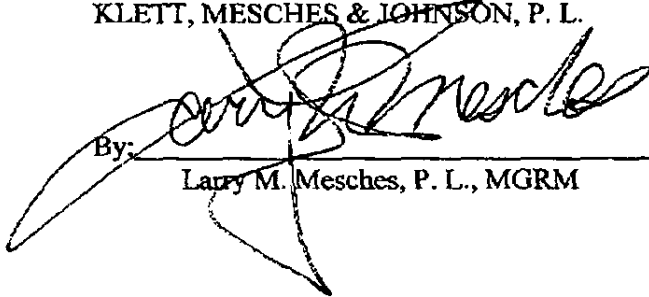

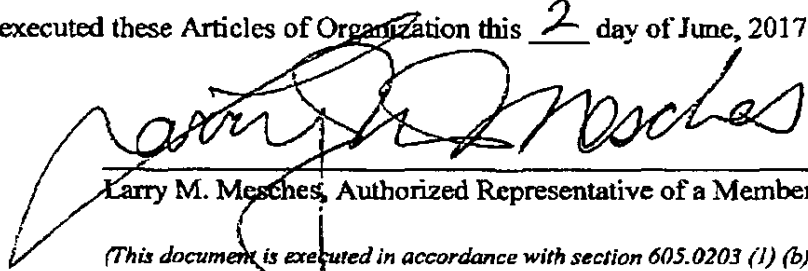
