The undersigned, Jason J. Alley, a natural person competent to contract and an authorized representative of No Shoes Resort Management, LLC, hereby presents these Articles of Organization as the Articles of Organization of No Shoes Resort Management, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I – NAME

The name of the limited liability company is No Shoes Resort Management, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."
