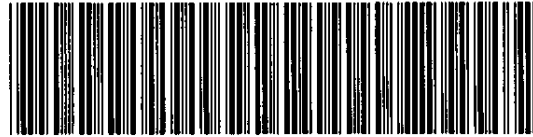

The mailing address and street address of the principal office of the Limited Liability Company is 2020 Salzedo Street, 5th Floor, Coral Gables, Florida 33134.


ARTICLE III - INITIAL REGISTERED AGENT


