**ARTICLE I – NAME**

The name of this limited liability company is UTZ-TILLMAN PARTNERSHIP LEASING LLC (the "Company").

**ARTICLE II – PRINCIPAL OFFICE / ADDRESS**

**ARTICLE VI – MANAGEMENT**

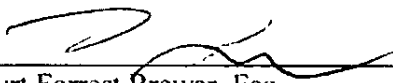
