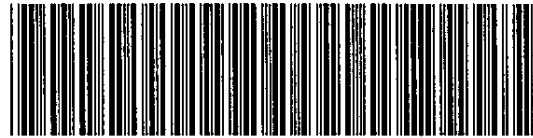

#### **ARTICLE VII - ADMISSION OF ADDITIONAL MEMBERS**




