ARTICLES OF ORGANIZATION OF JUPITER ISLAND WAY HOTEL, LLC

- 1. NAME. The name of this limited liability company is Jupiter Island Way Hotel, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.
