**ARTICLES OF ORGANIZATION
OF

The undersigned, J. Bruce Vredenburg, a natural person competent to contract and an authorized representative of ABIAD, LLC, hereby presents these Articles of Organization as the Articles of Organization of ABIAD, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is ABIAD, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The initial mailing address and principal office of the Company is 400 East Jackson Street, Pensacola, Florida 32501. The Company's mailing address and principal office may hereafter be at such other place or places as its members from time to time may determine.

ARTICLE III - PURPOSE AND POWERS

ARTICLE V - REGISTERED OFFICE AND AGENT

The initial registered office of the Company is 4550 Lassassier, Pensacola, Florida, 32504, and the name of the initial registered agent at that address is J. Bruce Vredenburg.

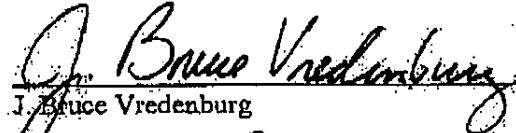

The Company shall be managed by one or more managers in accordance with the terms of the Operating Agreement for the Company. The names of the initial managers of the Company are as follows: -

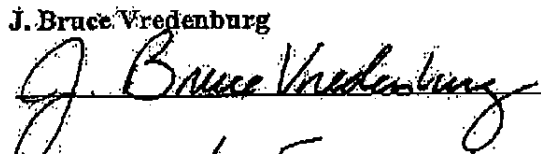
