The name and street address of the initial registered agent of the Company are Bruno S. Borges, 747 NE 195th Street, Miami, Florida, 33179.

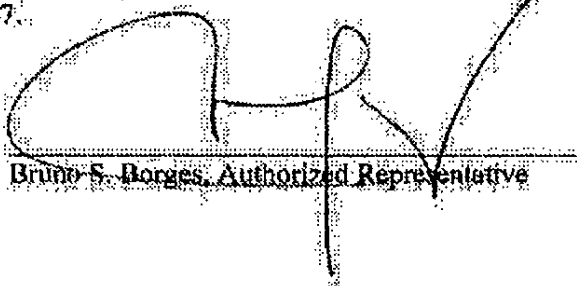
ARTICLE V. MANAGEMENT

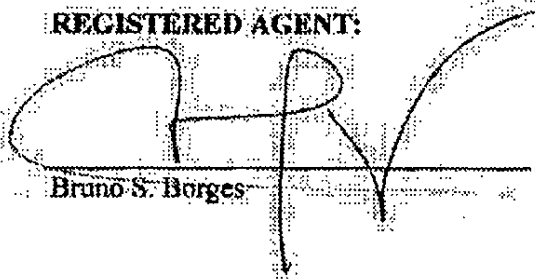
