ARTICLE I – NAME

ARTICLE VI – MANAGEMENT

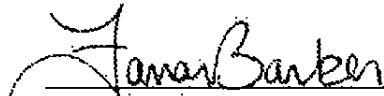

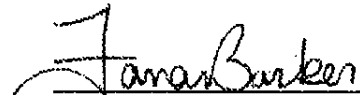
