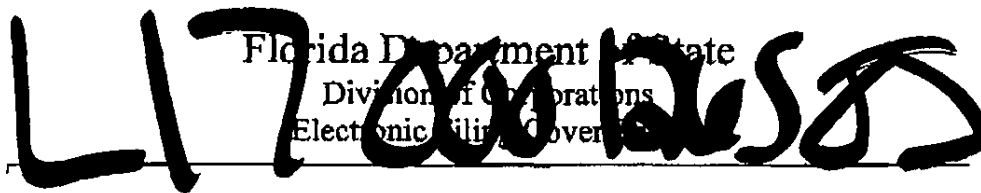


ARTICLE VII
