The mailing and street address of the principal office of the limited liability company is 5080 W, Newberry Road, Suite 2A, Gainesville, FL 32607.

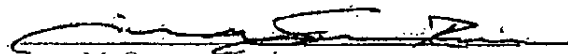
**ARTICLE III. REGISTERED AGENT AND OFFICE**
