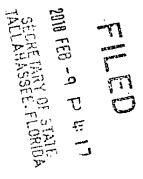

## MINKED BY MEECH, LLC AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF

A Member-Managed Florida LLC

The original articles of Organization were filed on June 12<sup>th</sup>, 2017. These Amended and Restated Articles of Organization of MINKED BY MEECH, LLC (hereinafter the "Company" or "MBM") have been duly executed and are being filed in accordance with Florida Chapter 605. The Amendments being made apply to All Articles of the original Articles of Organization.

#### I. ARTICLE I: Name

The name of the Limited Liability Company is MINKED BY MEECH, LLC.

#### II. ARTICLE II: Duration

Unless earlier terminated under by Statute or by the Operating Agreement, the period of duration of the Company shall be perpetual.

#### III. ARTICLE III: Purpose

The Company is organized for the purpose of engaging in any and all business activities related or having to do with eyelash application and other related beauty services, and all other lawful business and activities permitted by the laws of the State of Florida. The Company shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws.

#### **ARTICLE VIII: Continuity of Business**

On the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or on the occurrence of any other event that terminates the continued membership of a member in the Company, or upon any other event that, under the Act, would result in dissolution of the Company, the business of the Company may be continued and the Company will not be dissolved without the prior written consent of all the remaining members of the Company.

#### IX. ARTICLE IX: Management

This Company will be member-managed in accordance with the terms of the Operating Agreement.

#### ARTICLE X: Indemnification
