ARTICLES OF ORGANIZATION

of

The undersigned hereby forms and establishes a limited liability company pursuant to Chapter 605 of the Florida Statutes, as follows:

ARTICLE I

The name of this limited liability company is LLEB Holdings LLC (the "Company").

ARTICLE II

ARTICLE III

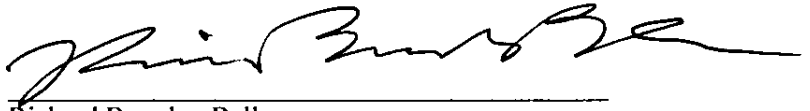
