**ARTICLES OF ORGANIZATION

4. Place of Principal Office. The mailing and street address of the Company's principal office is 6600 SW 114th Street, Pinecrest, Florida 33156.

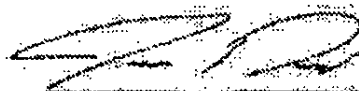
