**ARTICLES OF ORGANIZATION
OF
UHEALTH VENTURES HOLDING COMPANY, LLC
(A Florida Limited Liability Company)**

**ARTICLE I
NAME**

The name of the limited liability company is UHealth Ventures Holding Company, LLC (the "Company").

**ARTICLE II
ADDRESS**

The mailing address and street address of the principal office of the Company is 1120 NW 14th Street, Miami, Florida 33136.

**ARTICLE III
DURATION**

The period of duration for the Company shall begin on the date of filing these Articles of Organization with the Florida Department of State, and the Company shall have a perpetual existence and duration, until terminated in accordance with applicable law.
