The name of the Company shall be St. Marks Parking, LLC.

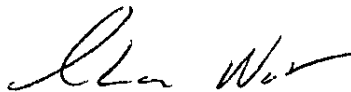
ARTICLE II. Principal Office

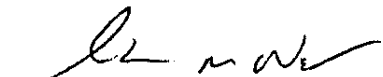
