THESE ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION OF AQUA EXPRESS CAR WASH LLC, a Florida limited liability company (the "Company"), are executed by the undersigned Authorized Representative of the Company for the purposes set forth herein:

1. The name of the limited liability company is AQUA EXPRESS CAR WASH LLC.

4. The Company has adopted the following amendments to the Articles of Organization:

ARTICLE I - NAME


The name of the limited liability company is AQUA VENTURES PROPERTIES, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS


