ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF AOUA EXPRESS CAR WASH LLC

THESE ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION OF AQUA EXPRESS CAR WASH LLC, a Florida limited liability company (the "Company), are executed by the undersigned Authorized Representative of the Company for the purposes set forth herein:

- 1. The name of the limited liability company is AQUA EXPRESS CAR WASH LLC.
- 2. The Articles of Organization were filed on June 21, 2017, and assigned document number L17000135499.
- The Company has approved to make the following changes to the Articles of Organization: (i) changing the name of the Company from AQUA EXPRESS CAR WASH, LLC to AQUA VENTURES PROPERTIES, LLC; and (ii) amending the principal office address of the Company.
 - 4. The Company has adopted the following amendments to the Articles of Organization:
 - I. Article I is hereby amended and restated in its entirety to read as follows:

ARTICLE I - NAME

The name of the limited liability company is AQUA VENTURES PROPERTIES, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

II. Article II is hereby amended and restated in its entirety to read as follows:

ARTICLE II - PRINCIPAL OFFICE ADDRESS
