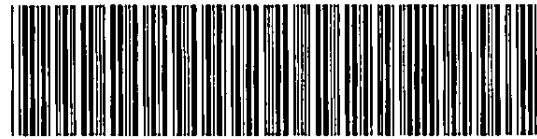

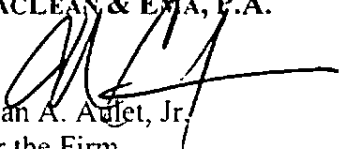

FOR
LORD PROPERTIES II, LLC**

(A Florida Limited Liability Company)

**ARTICLE I
NAME**

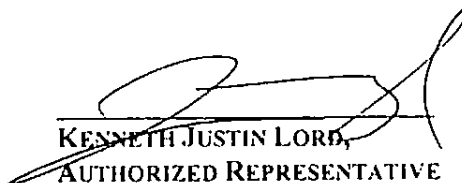
