**ARTICLES OF MERGER
OF
GLENWOOD SYSTEMS, LLC
(a Connecticut limited liability company)
WITH AND INTO
GLENWOOD SYSTEMS, LLC
(a Florida limited liability company)**

Pursuant to Section 605.1025 of the Florida Revised Limited Liability Company Act (the "Florida Act"), these Articles of Merger provide as follows:

**ARTICLE I
State of Organization; Constituent Entities**

The name, entity type and state of organization of each of the constituent entities of the merger are as follows:

**ARTICLE II
Surviving Entity**

Glenwood Systems, LLC, a Florida limited liability company (the "Surviving Entity"), shall be the surviving entity and shall be governed by the laws of the State of Florida, which state shall continue to be its domicile.

**ARTICLE III
Approval of the Plan of Merger**

The Plan of Merger was duly approved and adopted by the Surviving Entity in accordance with the provisions of Sections 605.1021-605.1026 of the Florida Act; by Glenwood Systems, LLC, a Connecticut limited liability company, in accordance with the provisions of the Connecticut Uniform Limited Liability Company Act; and by each member of such limited liability company who as a result of the merger will have interest holder liability under Section 605.1023(1)(b) of the Florida Act.

ARTICLE IV
Appraisal Rights

To the extent that any member has appraisal rights, the Surviving Entity has agreed to pay such member the amount to which such member is entitled pursuant to Sections 605.1006 and 605.1061-605.1072 of the Florida Act.

ARTICLE V
Effective Time

The merger shall become effective upon the filing of this Articles of Merger with the Department of State of the State of Florida (the "**Effective Date**").
