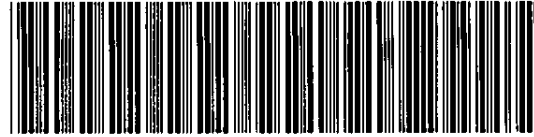

The Limited Liability Company shall have perpetual existence commencing on June 19, 2017.


