## ARTICLES OF ORGANIZATION OF VETERANS MAINTENANCE SERVICES, L.L.C.

- 1. Name. The name of the limited liability Company (he referred to as "Company") is: VETERANS MAINTENANCE SERVICES, L.L.C.
- 2. <u>Existence</u>. The Company shall have perpetual existence commencing with the date of filing.


