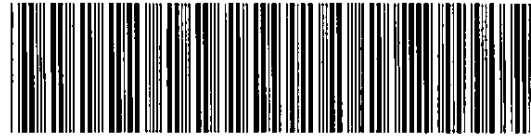


ARTICLE I – Name: The name of the Limited Liability Company is Djshomemade, LLC.
