ARTICLE II - PRINCIPAL OFFICE


The mailing address and the street address of the principal office of the Company is 270 W. New England Avenue, Winter Park, Florida 32789.

ARTICLE IV - MANAGEMENT


The Company is a member-managed limited liability company and the initial manager of the Company is Chad Hagle, 270 W. New England Avenue, Winter Park, Florida 32789.
