The name of this limited liability company shall be **FIRST LIGHT CONSULTANTS, LLC** (the "Company").

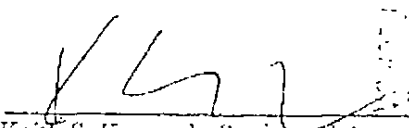

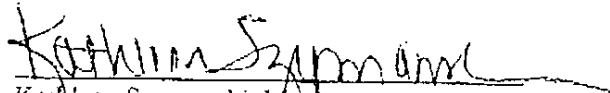
