ARTICLES OF DISSOLUTION OF

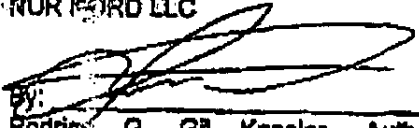
NUR NORD LLC
