
**ARTICLE VII  
NEW MEMBERS**



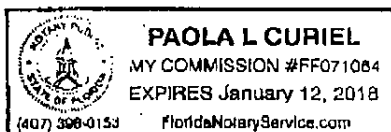
