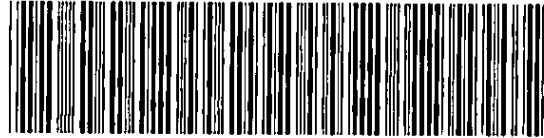

**ARTICLE III**


Purpose

Registered Agent


