**ARTICLES OF ORGANIZATION
OF

The undersigned, William E. Wallace, a natural person competent to contract and a member of Clam I Am, LLC, hereby presents these Articles of Organization as the Articles of Organization of Clam I Am, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Clam I Am, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The initial registered office of the Company is 1201 Hays Street, Tallahassee, Florida 32301, and the name of the initial registered agent at that address is Corporation Service Company.

ARTICLE VI - MANAGEMENT

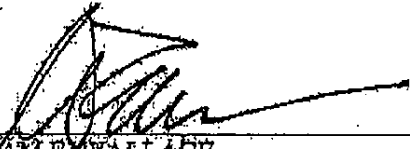
