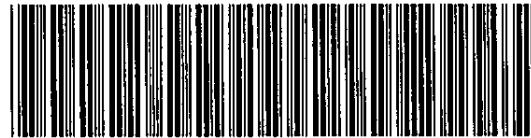

ARTICLES OF ORGANIZATION
OF

Pursuant to Chapter 605 of the Florida Statutes, the undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I: The name of the Limited Liability Company is "DICKINSON SERVICES, L.L.C.".

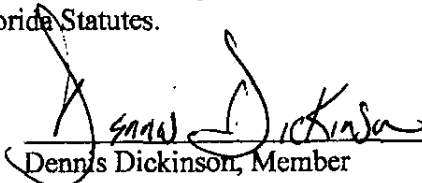
