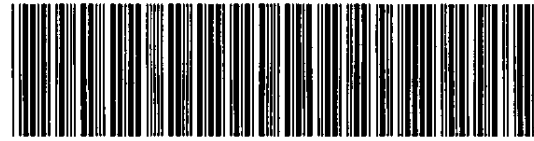



**FIRST:** Amendment adopted: ARTICLE V of the Articles of Organization CVR REALTY LLC shall be amended as follows:


