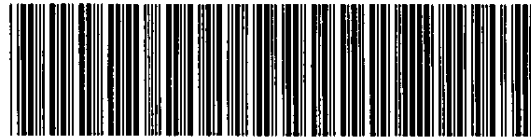



ARTICLES OF AMENDMENT
