**ARTICLES OF ORGANIZATION
OF

The undersigned, being a duly authorized representative of the Member(s), desiring to form a limited liability company under and pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes (the "Act"), does hereby adopt the following Articles of Organization:

ARTICLE I. NAME

The name of the limited liability company is TECH HANNA & ISSAM, LLC (the "Company").

ARTICLE II. ADDRESS

The principal and mailing address office of the Company is 701 Brickell Avenue, Suite 3300, Miami, Florida 33131.

ARTICLE III. REGISTERED AGENT AND OFFICE
