

ARTICLES OF ORGANIZATION OF PRIME MARINA SA HOLDINGS, LLC

These Articles of Organization are submitted for the purpose of forming in its liability company pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, as the same may from time to time be amended, superseded or replaced (the "Act").

ARTICLE I - NAME

The name of this limited liability company (the "Company") is Prime Marina SA Holdings, LLC.

ARTICLE II - ADDRESS

ARTICLE III - INITIAL REGISTERED OFFICE AND AGENT
