ARTICLES OF ORGANIZATION OF FISH TALE MARINA RESTAURANT, LLC

The undersigned certifies that he is acting as an authorized representative for the purpose of forming a limited liability company under the laws of the State of Florida providing for the formation, rights, privileges, and immunities of limited liability companies for profit. 6.
