The name of the Limited Liability Company shall be **Marylou Johnston, LLC**, and its principal office is to be located in Leon County, Florida.

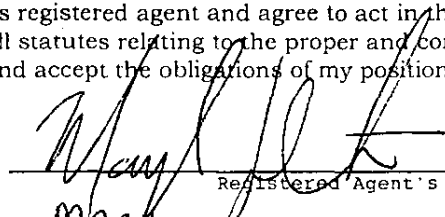
ARTICLE II. - PRINCIPAL OFFICE

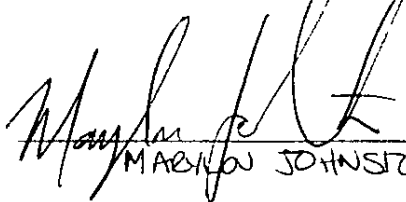
ARTICLE VI. - PURPOSE

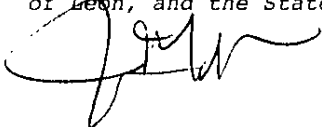
